


Ambient Lead Levels in New England

Strengthening the Lead Monitoring Network- Location

- According to NE States- there are no lead sources in excess of 1 ton per year (TPY).
- Eight New England areas that are CBSAs greater than 500,000
 - Boston-Cambridge-Quincy, MA-NH
 - Providence-New Bedford-Fall River, RI-MA
 - Hartford-West Hartford-East Hartford, CT
 - Bridgeport-Norwalk-Stamford, CT

 - Springfield, MA
 - Portland-South Portland-Biddeford, ME

Strengthening the Lead Monitoring Network- Location

 - San Juan-Caguas-Guaynabo, PR
 - Syracuse, NY

(Need to utilize high vol TSP monitor if $0.10 \mu\text{g}/\text{m}^3$ is exceeded)
- Interest/ need to monitor elsewhere? (larger sources, general aviation airport, race tracks)
