
### Why needed?

- Recent court cases vs. EPA regarding Clean Air Act implementation guidance;
- Updated EPA implementation guidance during July-August 2016;
- Partial disapproval of 2012 Oakridge Attainment Plan by EPA in July-October 2016; and
- Failure to attain 24-hour standard by the Clean Air Act deadline of December 2015, but CAA deadline extension to December 2016 approved by EPA Administrator.



### Oakridge history – PM<sub>10</sub> standards attained on schedule in mid-1990s:


Inhalable Particulate Matter (PM10) Trend in Oakridge





### Initial PM<sub>2.5</sub> standards attained by 1999, but continued improvement needed to meet 2006 PM<sub>2.5</sub> standards :


#### Respirable Particulate Matter (PM2.5) in Lane County






### Oakridge air quality has improved but has fluctuated (along with other nearby sites) with weather:

#### Respirable Particulate Matter (PM2.5) on Worst Days






# The chemistry indicates most of the particulate is organic carbon, consistent with woodsmoke:


### Updated Oakridge-Westfir PM2.5 Attainment Plan

### Key components of 2016 updated plan:

- Code enforcement officer hired by City of Oakridge with LRAPA field compliance officer support;
- Continued HeatSmart woodstove replacements upon home sale, and continued ductless heat pump installations by Lane Electric;
- Tightened City ordinances, including 20% opacity limits and lower curtailment cutpoints; and
- Extended daily red-yellow-green woodburning advisory season (from Nov-Feb to Oct-May).




### Many community partners were involved in outreach programs to improve cooperation and burning practices.






### Air quality in Oakridge in 2016 was the best ever recorded, breaking the previous record set in 2015.









#### Oakridge PM2.5 Attainment Plan Approval Process

- Lane Regional Air Protection Agency (LRAPA) Board of Directors adopted the Updated Oakridge-Westfir PM<sub>2.5</sub> Attainment Plan in November 2016.
- Oregon Environmental Quality Commission (EQC) incorporated the Attainment Plan into the Oregon Clean Air Act State Implementation Plan (SIP) in January 2017.
- The U.S. Environmental Protection Agency (EPA) approved the Attainment Plan in the February 8, 2018 Federal Register (83 FR 5537) effective March 12, 2018.
